### 2024/25 Hunter Mentor Pledge Giveaway Official Rules

*Please read these Official Rules carefully, as they contain important information about the rights and obligations, as well as limitations and exclusions that may apply, to participate in this promotion. By entering, participants signify and agree to these Official Rules and the decisions of Sponsor.*

- **PURPOSE:** The purpose of the Mentor Pledge is to encourage hunters to share our outdoor lifestyle by introducing or re-introducing people to hunting.
- **ELIGIBILITY:** NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR CLAIM PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. Open to legal residents of the 50 United States and District of Columbia (“U.S.”) who are 18 years of age or older at time of entry. Employees of Pheasants Forever Inc. are not eligible. The Pledge giveaway is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
- **AGREEMENT:** By participating, you agree to be fully and unconditionally bound by these rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of Pheasants Forever Inc. as final and binding as it relates to the contest.
- **ENTRY:** The giveaway must be entered by submitting an entry using the online form on the website landing page. Entries will be accepted online starting on 7/1/2024, and ending 6/30/2025 at 11:59 PM EST. You may enter only once per unique new or beginning hunter that you mentored, and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. All entrants must follow state and federal rules/regulations for the species they are hunting.
- **ODDS:** The odds of winning depend on the number of eligible entries received.
- **SELECTION:** The winner of the giveaway will be selected in a random drawing. The winner will be notified via phone and email to the address they entered for the giveaway. If the selected winner

cannot be contacted, is ineligible, fails to claim the prize within 30 days from the time award notification was sent, or fails to return in a timely manner a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.

- **FIREARMS:** Guns awarded as prizes will be distributed through a licensed dealer and only in compliance with federal and state laws and applicable local ordinances.
